PLAINTIFFS' REPORT
ON THE FINAL RESOLUTION OF THE DHA REIMBURSEMENT OF
WALKER SETTLEMENT VOUCHER TENANTS'
PAYMENT STANDARD CLAIMS

The Court's April 17, 2014 Order, Document 2759, required DHA to calculate and use the correct Walker Settlement Voucher Payment Standard for all Walker Settlement Voucher households. The Court took the issue of reimbursement under advisement but ordered the parties to conduct an attempt to resolve 25 of the claims and report to the Court on the process. Pages 2, 3. The parties complied and subsequently agreed to a process for the resolution of the claims.¹ This is a report on the final status of the claim reimbursement process.

As of December 13, 2016 DHA and Plaintiffs' counsel had agreed to the reimbursement calculations for all Walker Settlement Voucher (WSV) clients potentially affected by DHA's failure to apply the correct Walker Settlement Voucher payment standard. The calculations resulted in an agreed total reimbursement of \$512,187.35 for 410 Walker Settlement Voucher clients. Plaintiffs and DHA calculated that no reimbursements were due for 103 WSV clients.
